






# Scan QR Code to Add Device




Enter "Scan".






Scan the QR code on the device.




Long press the pairing button for 5 seconds.

Place the device in your desired place and press the device's pairing button, then the signal icon (a) on the screen keeps on, which means the device and the device (router device or gateway)


# Installation

#### 1. Place on the desktop




Open the stand and place it.

2-2 Stick on the wall with 3M adhesive base.


